The Safety group is a complete system that protects closed-loop heating systems and potable water installations from hazardous pressure increase caused by growth of water temperature and thermal expansion of water in line. Safety groups for central heating systems are designed for installations in water-based central heating systems (heat systems rated up to 50kW). The different types of safety groups differ in the pressure graduation for manometers and membrane safety valves.
